EXPERIENCE

General Litigation: I have litigated, investigated, researched, and successfully resolved a variety of cases for over twenty five-years, including but not limited to housing discrimination and prisoner rights civil rights cases in federal, state, appellate and local administrative jurisdictions. I serve as the director and mentor to clinical supervising attorneys and law students in all aspects of civil litigation and criminal matters. Additionally, I teach, lecture, and educate conference participants on civil rights laws and appellate procedure, including advanced training for lawyers. I organize seminars in Illinois

communities and educate community members of their legal rights, legal procedures, and federal and local laws. I draft proposals apply for and receive funding from federal, state, and local governmental agencies. I also teach civil rights, Illinois Civil Procedure, legal writing, and other school courses. I currently serve as the Director of the Pro Bono Litigation Clinic, which engages in all aspects of civil and criminal matters.

SIGNIFICANT CASES

In *Lackey v. Godinez*, 352 Ill. App. 3d 87, 815 N.E.2d 822 (1st Dist. 2004), I file suit alleging "source of income" discrimination under the Chicago Housing Ordinance on behalf of Ms. Lackey. Ms. Lackey was denied a rental unit solely because she intended to pay her rent with her Section 8 voucher. I briefed and argued that Section 8 is a legal "source of income" as defined by the Chicago Housing Ordinance. The case clarified the Chicago Ordinance and provides housing to Section 8 participants without discrimination solely because of their "source of income". This opinion has been relied upon in other similar housing discrimination cases thorough the country.

Co-authored the *amicus curiae* brief accepted by the Seventh Circuit in *Wisconsin Community Services* v. City of Milwaukee, 465 F.3d 737 (7th Cir. 2006). I argued that the Fair Housing Act establishes a duty to make a reasonable accommodation for a person with a disability, absent of proof that the rule, policy, practice, or service is itself illegal because of intentional discrimination or disparate impact. The Seventh Circuit in *en banc* review agreed with our position and reversed the panels finding.

In *Ho v. HUD*, 569 F.3d 677 (7th Cir. 2009), on petition for review, Ho argued that the ALJ's default judgment of liability and assessment of damages against her deprived her of due process. The codefendant argued that the ALJ's default judgment of liability and assessment of damages arbitrarily departed from HUD and Circuit precedent. The government and I responded to these claims and crosspetition for enforcement of HUD's final order. The Seventh Circuit affirmed the ALJ's decision in our favor.
