The Fair Housing Legal Support Center plans and oversees conferences on fair housing law, responds to inquiries from attorneys and organizations on fair housing law, and prepares fair housing informational materials for attorneys and the general public. The Center has conducted trainings in Fair Housing Investigations and Conciliation for HUD investigators and enforcement personnel. The Center has planned, prepared materials for, and participated in fair housing trainings for agencies and organizations throughout the United States. He is a regular speaker at conferences and trainings throughout the United States on fair housing law and enforcement.

In 2004, he organized a course at The John Marshall Law School on Fair (Anti-Predatory) Lending and Home Preservation Law. As part of the course, law students went out into the community to educate persons about predatory home lending issues and to review lending documents of borrowers to see if they contain terms that may be predatory. The course and project were originally funded by the Fannie Mae Foundation and later through grants by HUD and the City of Chicago. The project was later funded by a grants from the City of Chicago to educate seniors about reverse mortgages and other consumer matters. He has also pioneered a course on Fair Housing/Fair Lending Law for college and university students, both graduate and undergraduate, in the Chicago Metropolitan area. The Course was funded by a grant from HUD.

Executive Director, The John Marshall Law School Fair Housing Legal Clinic (1992 - 2015)

Supervised clinical attorneys and consulted with students who investigate and litigate fair housing cases in both administrative and judicial forums. Also responsible for securing foundation and government funding for the operation of the first law school clinic in the United States that handles solely issues involving housing discrimination.

Director, UIC Law School Restorative Justice Project (Since 2010)

Served as co-director with Judge Sheila M. Murphy (ret.) until Sept. 2022 and since then as director of the Restorative Justice Project. The project brings the intersection of restorative justice tools and techniques to law students. The Project trains students and new lawyers about restorative justice so that they realize that the application of justice is not just punitive but also restorative.

The Project is bringing restorative justice practices, tools, and techniques to students in Chicago's schools and the Union League Boys' and Girls' Clubs as an effort to stop truancy and anti-social behavior in the schools and to eliminate violence in the community. The project produces learning materials and educates the public about restorative justice. It has published two books of essays on restorative justice.

In addition to teaching, he has served as counsel in civil rights cases and appeals in the state and federal courts. Most of these cases have involved constitutional or public law issues. Co-counsel in a suit attacking the Illinois Residential Picketing Statute under the First Amendment, Carey v. Brown, 447 U.S. 455 (1980), and in an appeal to the Supreme Court on the validity of a referendum that excluded affordable housing under the Equal Protection Clause, City of Cuyahoga Falls v. Buckeye Community Hope Foundation, 538 U.S. 188 (2003). He also litigated cases under the Voting Rights Act in the federal court against the Cook County judiciary and the City of Chicago Heights, Illinois.

Directing Attorney for the Land of Lincoln Legal Assistance Foundation in Cairo, Illinois (July 1972 to August 1976)

The office opened in 1969 as a special project of the Lawyer's Committee for Civil Rights under Law and merged (administratively) with other downstate Illinois legal services offices in 1972. While in Cairo, he worked on civil rights and poverty law problems for Alexander, Pulaski and Union Counties, Illinois. These counties are statistically the poorest in the state, and they have a long history of racial polarization and conflict. The Lawyers' Committee opened its office in Cairo at a time when violence and shootings were a daily occurrence in the city. By channeling civil rights complaints through the courts, the office helped defuse the violence and improve racial relations in this troubled city. For an account of the Cairo activities, see 61 Ore.
